1.) T. Hinojosa was the first Co-Chair of the Hispanic Affairs Committee which later became the Latino Affairs Commission. She was the first Coordinator to the Commission and still has the

original paperwork from the first few years of the Commission's existence and other related documents.

2.) The Commission was the catalyst for the development of the Human Services Department's Cultural Competence Standards for Community Programs that were supported by the County in the early 2000s. The Board of Supervisors furthered this work by asking the Personnel Department to develop Cultural Competence guidelines for all departments in 2003. The Commission helped create the five basic Cultural Competence Standards that County departments use to carry out their programs and services.

3.) The Commission originally took on multiple focus areas including education, economy, health, inequities in the justice system and the social environment. A task force was created based on the Commission's findings to look into disproportionate minority contacts within the justice system and overcrowding at juvenile hall. The Criminal Justice Council was formed out of this task force to provide a forum for discussion, make recommendations for programs and develop solutions to address criminal justice issues.

4.) The Commission was instrumental in stressing the need for Santa Cruz County Programs to be able to better serve the Latino community. The Latino Equity Report was created by the Latino Executive Directors (LED) and it promoted equitable funding for non-profit organizations.

5.) Discussion about how many Latinos are currently utilizing services and how Latinos are defined ensued amongst Commissioners.

6.) Suggestions for how and where the Commission could focus their attention were provided including building awareness of the Commission.

b.) R. Hernandez Rosser will contact the UCSC Library regarding archiving the original Latino Affairs Commission materials. The Commission will strategize ways to share these materials with the community.

c.) Create a subcommittee to work on a Cultural Competence Plan.

Motion/ Second: del Franco/ Nieto. Passed unanimously.
