#### 4. New Business/Action Items

4.1. Immigration Policy: Review Community impact and Response and Consider Next Steps
The Commission discussed community concerns related to immigration enforcement and
access to services. Rocha and Flores reported on local organizing efforts and the work of YARR
in providing rapid response and safe spaces for allies. The Commission agreed to draft a letter
to the Board of Supervisors highlighting community concerns, including the use of masks by
ICE officers, potentially problematic County investments, the need for increased funding for
services and safety net benefits for families impacted by ICE activities, avoiding hiring
individuals with prior ICE employment for County law enforcement roles, and ensuring the
confidentiality of data collected by the County, such as automatic license plate reader data.

Motion to establish an ad hoc *Immigration Policy Subcommittee* to draft a letter to the Board of Supervisors sharing community concerns

Motion/Second: De Santos/ Flores Martinez

Motion passed unanimously.

Nevarez appointed Nevarez, Lopez, Rocha, and Flores-Martinez to the subcommittee.

  Sargeant's classification among Peace Officers and Special Teams.

  The subcommittee met to discuss visual themes for the exhibit. Staff requested additional information and photographs from Community Action Board and will work with the Board of Supervisors to draft a proclamation honoring CAB's achievements.

Re: Community Concerns Related to Immigration Enforcement and Access to Services

Dear Chair Hernandez and Members of the Board,

Under the provisions of Santa Cruz County Code 2.117.050(A), the Latino Affairs Commission is mandated to advise your Board of issues and concerns affecting the Latino community. The following concerns impacting the Latino immigrant community were brought forward during the last Commission meeting:

- The presence of <u>masked</u> ICE officers undermines trust, unnecessarily increases anxiety, (particularly around whether the masked individuals are imposters), and makes County residents feel unsafe in public spaces.
- County investment funds may include investments in companies with problematic human rights records which raises concerns that County government may be indirectly supporting entities whose practices conflict with their expressed values of equity and human dignity.
- Community members impacted by ICE activities have expressed challenges accessing medical care, food security programs, and other supports essential to family stability and wellbeing.
- There are concerns that current Sheriff's Office hiring practices may not sufficiently account for prior ICE employment which could erode trust in local law enforcement and discourage residents from seeking help when needed.
- Community members are worried about how information—particularly that collected by automatic license plate readers—may be stored, shared, or accessed, and whether it could be used in ways that harm immigrant residents.

The Commission shares these concerns with you to help inform your deliberations and policy decisions impacting County immigrants. We respectfully urge your Board to weigh these community concerns carefully as part of your ongoing commitment to equity, safety, and inclusion in Santa Cruz County.

#### **Major 2025 California Laws Protecting Immigrants**

#### 1. Immigration Enforcement Restrictions in Schools (AB 49) – Effective Immediately

This law prohibits immigration enforcement officers from entering nonpublic areas of schools or child care facilities without a valid judicial warrant, subpoena, or court order. It also requires school officials to request identification from such officers and restricts the disclosure of student information to immigration authorities without proper legal authorization.

#### 2. Healthcare Facility Access (SB 81) - Effective Immediately

SB 81 prohibits immigration enforcement from entering restricted areas of health facilities without a judicial warrant or court order. This measure is intended to protect patients' rights and ensure that healthcare settings remain safe and accessible for all individuals, regardless of immigration status.

3. Sending Alerts to Families in Education (SAFE) Act (SB 98) – Effective Immediately SB 98 mandates that: K–12 schools and higher education institutions must promptly inform students, parents, faculty, staff, and other campus community members when immigration enforcement officers are present on campus; Educational institutions are required to update their comprehensive school safety plans to include procedures for notifying the school community about ICE activities; and prohibits the collection of information regarding the citizenship or immigration status of students or their family members, except as required by state or federal law.

#### 4. No Secret Police Act (SB 627)

Signed into law on September 20, 2025, this legislation prohibits most federal and local law enforcement officers from wearing masks that conceal their identities during operations. Exceptions are made for undercover agents, medical masks, and tactical gear. The law aims to increase transparency and accountability in law enforcement, particularly in immigrant communities.

#### 5. Immigrant and Refugee Inclusion Fund (SB 12)

SB 12 establishes the Immigrant and Refugee Inclusion Fund within the State Treasury, designed to support programs that assist immigrants and refugees. The bill also limits interagency sharing of personal information about immigrants and refugees, aiming to protect their privacy and prevent data from being used for immigration enforcement purposes.

#### 6. Family Preparedness Plan Act (AB 495)

This act requires the state to develop and implement a family preparedness plan to support immigrant families in the event of immigration enforcement actions. The plan includes providing legal resources and assistance to help families navigate potential challenges and maintain stability.

These legislative actions reflect California's commitment to safeguarding the rights and well-being of immigrants within the state.

# Santa Cruz County Latino Affairs Commission 2024 - 2025 Biennial Report

#### 1. THE ROLE OF THE COMMISSION

The Latino Affairs Commission is an advisory body to the Board of Supervisors on issues affecting the Latino community in Santa Cruz County. The Commission was established to:

- a. Advise the Board of Supervisors on any significant problems currently encountered by the County's Latino residents;
- b. Review the needs of Latino citizens in the County, and recommend comprehensive goals and objectives for effectively meeting those needs;
- c. Monitor the various services made available to Latino citizens by public and private agencies in the County and make recommendations to the Board of Supervisors on how County government can help ensure effective and efficient delivery of those services;
- Develop a procedure to identify and set priorities regarding the areas of greatest need for County support and/or attention, and prepare biennial recommendations to the Board of Supervisors regarding specific courses of action in response to identified needs and priorities;
- e. Advise the Board of Supervisors how best to cooperate with local, State, Federal and private agencies serving Latino citizens, and assist in the preparation, implementation, and review of any regional plan or program designed to serve Latino citizens;
- f. Advise the Board of Supervisors how best to cooperate with local, State, Federal and private agencies in order to maximize the availability of funds to meet the specific economic needs of the Latino population, with the objective of leveraging such funds to the greatest degree possible.

#### 2. MEETINGS DATES, TIME, AND LOCATION

Latino Affairs Commission meetings are scheduled for the first Wednesday of every other month (February, April, June, August, October, and December), from 6:00 until 7:30 PM at the United Way of Santa Cruz County office (4450 Capitola Rd, Suite 106, Capitola, CA 95010) or at a site in Watsonville when possible.

- In 2024, one regularly scheduled meeting was canceled for lack of quorum.
- In 2025, two of the six regularly scheduled meetings were canceled for lack of quorum.

#### 3. COMMISSION STRUCTURE

The Latino Affairs Commission is composed of seven voting members; one Commissioner appointed by each of the five District Supervisors to represent their districts, and two at-large Commissioners each, appointed by the cities of Santa Cruz and Watsonville to represent their cities. Commission leadership (Chair and Vice Chair) elections are held each year during the April regular meeting.

#### 6. OBJECTIVES AND ACTIVITIES

service to the Latinx community. Supervisor Cummings presented a proclamation
recognizing CAB's hard work and many efforts to support County Latinos, particularly in
the wake of increased immigration enforcement activity.

- Monitor County engagement with immigration-related events and advocate for the safety and wellbeing of Santa Cruz Count immigrants
- Monitor ongoing efforts to support economic recovery from all recent disasters including wildfires, debris flow events, flooding and storm damage, and pandemic-related impacts.
- Monitor County efforts to address the housing crisis, provide housing and services to unhoused residents, and increase the availability of affordable housing particularly for the Latinx community
- Revise Commission bylaws
- Promote awareness of the Commission by attending and supporting local events aligned with the Commission's scope and purpose

## In 2026-2027, the Latino Affairs Commission recommends that the Board of Supervisors take the following actions:

- Continue to provide policy leadership and funding support to County efforts designed to support and protect County immigrants impacted by immigration enforcement activities
- Continue to provide policy leadership and funding support to County efforts designed to ensure diversity, equity and inclusion in County programs, services and workforce
- Provide policy leadership and funding support to study Latinx representation in County law enforcement leadership roles and address inequities if any.
- Provide policy leadership and funding support to programs supporting health equity in the Latinx community
- Continue to provide policy leadership and funding support to agencies and programs designed to address the housing crisis, unhoused residents, and the availability of affordable housing, particularly in the Latinx community.
- Provide policy leadership and funding support to programs tasked with expanding broadband access to underserved areas of the County, particularly those where a technology gap may be disproportionately impacting the Latinx community
